THERE ARE OVER 400 ROUND DISC'S THAT HAVE NUMBERS ON THEM. THESE DISCS ARE USED BY THE CEMETERY COMMITTEE, FUNERAL HOMES AND EXCAVATORS IN LOCATING THE CORNERS OF EACH BURIAL PLOT WHEN REQUIRED.

## FINANCIAL SUPPORT

THE CEMETERY FUND IS SEPARATE FROM ALL OTHER CHURCH FUNDS, AND THE EXPENSES FOR THE CEMETERY CONTINUE TO BE PAID FROM THAT FUND. THE RECURRING EXPENSES ARE FOR THE GENERAL MAINTENANCE OF THE GROUNDS: CUTTING THE GRASS, WEED CONTROL, VARMINT CONTROL AND ACCESS IN AND OUT FROM THE NEW ELAM CHURCH ROAD SIDE, OR EAST SIDE, OF THE PROPERTY.

THE CEMETERY IS FUNDED PRIMARILY THROUGH 1) INDIVIDUAL DONATIONS INCLUDING NON CHURCH MEMBER DONATIONS FOR ACQUIRING CEMETERY PLOTS, AND 2) THE MEMORIAL DAY CHURCH SERVICE COLLECTION.
